  - If drawing set is less than 30 sheets, a grouped pdf electronic file can be emailed or provided for download in lieu of hard copies.
- A check for the appropriate fee made payable to Winning Way Services, Inc.
- This signed and completed form authorizing Winning Way Services, Inc. to perform the TAS plan review.

### PLAN REVIEW FEE SCHEDULE
